RELEASE AND WEIVER OF LIABILITY AND INDEMNITY AGREEMENT RUNNING T RANCH ROUND UP MARCH 31ST - APRIL 2ND

The undersigned si a voluntary participant, or parent or legal guardian of a voluntary minor participant, ni the above- referenced event (the "Event") held at the Roling Hils Casino Equestrian Facility (the "Facility"), which isowned and operated by the Rolling Hills Casino. The Event issponsored by: RUNNING T CATTLE CO., LLC (the "Event Sponsor*).

ine undersigned acknowledges that the Event Sponsor and Rolling Hils Casino, and their officers, agents, and employees, have not made, and do not make, any representation or warranty of any kind, express or implied, ni connection with the Event, the undersigned's participation therein, or the safety of hte arenas, roads, paths, trails, bridges, properties, campsites, horses, and animals used during the Event. If the undersigned believes that anything encountered at the Event is unsafe, he or she shall immediately advise Event Sponsorand leave thearea

The undersigned acknowledges that the activities of the Event are POTENTIALLY DANGEROUS AND INVOLVE THE RISK OF SERIOUS INJURY AND DAMAGE TO BOTH PERSON AND PROPERTY, INCLUDING THE RISK OF DEATH. In consideration of allowing the undersigned to participate in the Event and to enter upon the Facility, the undersigned expressly assumes any and all risks associated with such activity, including, but not limited to, all risks incidental to traveling to or from the Event, participating in the Event, horseback riding, arena activities, use of his or her horse or another(s) horse, close proximity to horses and other animals and related equipment, and overnight camping on improved or unimproved land.

In consideration of being permitted to participate in the riding and arena activities conducted at the Event and held at the Facility, the undersigned for himself or herself, his or her personal representatives, heirs, next of kin, and successors, acknowledges, agrees, and represents that he or she hereby:

- 1) WAIVES, DISCHARGES, AGREES NOT TO SUE AND RELEASES THE EVENT SPONSOR, ROLLING HILLS CASINO, THE PASKENTA BAND OF NOMLAKI INDIANS, and any of their officers, agents, or employees, and each of them and their agents (collectively called "Releasees"), from any and al actions, claims, damages, liabilities, disabilities, or expenses of any kind that arise out of, pertain to, or relate to the undersigned's participation in the Event, or presence at the Facility.
- 2) AGREES TO INDEMNIFY, SAVE, AND HOLD HARMLESS the Releases and each ofthem, from any claim, loss, liability, damages, costs or other expenses, including attorneys fees and costs and expert witness fees and costs, they may incur while the undersigned is attending the Event, or traveling to or from said Event, whether causedby the negligence of the Releasees or otherwise.
- 3) EXPRESSLY ACKNOWLEDGES that this Release and Waiver of Liability and Indemnity Agreement is intended to be as broad and as inclusive as si permitted by the laws ofthe State of California. Ifany portion of the Agreement is held invalid, it is further agreed that the remainder of the Agreement shall continue in full force and effect.

Therelease and indemnity obligations set forth herein shall apply whetherornot the Releases, or any of them, werethemselves negligent with regard to any act causing any damage or injury; provided, however, that the release and indemnity provisions shallnot applysto the specific Releasee ni the event that any damage or injury is caused by the sole gross negligence or solely by the intentional wrongful act of that particular Release. In such event, the release and indemnity provisions hereunder shall continue of apply to other Releases. Nothing ni this agreement shall constitute a waiver of sovereign immunity, express. or implied. This agreement shall be binding upon the undersigned's heirs, executors, successors, and assigns.

THE UNDERSIGNED HAS READ THIS AGREEMENT NI ITS ENTIRETY AND VOLUNTARILY SIGNS THIS DOCUMENT KNOWING THAT IT CONSTITUTES A WAIVER OF LIABILITY AND AN INDEMNITY AGREEMENT. NO ORAL REPRESENTATIONS HAVE BEEN MADE CONTRARY TO THIS AGREEMENT
