Horse ID Form

Each horse ridden in approved WSVRHA events must be assigned a permanent WSVRHA Identification Number. This number will be lifetime identification and remain with the horse regardless of ownership.

Prior to participation in an approved WSVRHA event, a completed Horse Identification Number Application Form must be provided to WSVRHA (either to the office prior to the event or to show management at the event). The Ranch Horse Identification Number will be assigned to the horse by WSVRHA. The rider will be responsible for providing the Horse ID Number at all following approved events.
