75 & higher - Total control, excellent form & position on cow, high degree of difficulty, excellent eye appeal. 73-74 - Good form & position on cow, good control of cow, high degree of difficulty with good eye appeal 71-72 - A credit earning run with correct form and position, better than average control of cow with some degree of difficulty and eye appeal.

70 - Control, correct form, average dregree of difficulty. 68-69 - Slight loss of form or position on cow. Average degree of difficulty and eye appeal. good work with a major penalty (3 or 5) or average work with 1 point penalties.

66-67 - Trouble controlling cow and/or rider/horse is out of position. Loss of eye appeal.

65 & below - Incurs major penalties, loss of control and position. Total lack of credit.
