AWARDS

Way Out West Award will be given to the top money earner in each division!

All Around AQHA VRH: To be eligible one horse and rider team must show in one cattle class, one non-cattle class, and a ranch conformation class. Points are awarded per class entered.

Ranch Rail is not considered a non-cattle class.

All Around GSVRHA: To be eligible, one horse and rider team must be entered in all 5 versatility classes. Points are awarded based on all around entries. Ranch Rail and Conformation is not considered a class towards all around.

Way Out West Award: A new Way Out West Award will be given to the top money earner in the Ranch Riding, Ranch Trail, and Ranch Rail. You must show in all 3 non-cattle classes on Saturday to qualify for this award.

ALL BREED CLASS INFORMATION

AQHA VRH rules will apply for All Breed classes and AQHA VRH divisions will be used. Jackpot and ADDED MONEY will be awarded to ALL classes with 5 or more entries! Youth classes are not eligible for jackpot money. Awards will be given in youth classes.

NEW CLASS: Ranch Rail will be an All Breed class ONLY! It does not count towards the all around but goes twards the WOW Award on Saturday.

GSVRHA

GSVRHA is an all breed association that requires a membership to earn points and awards. Find more info at gsvrha.org

GS offers subdivisions (Ad-ons) which include Jr. Horse (age of horse is between 3-5) and Select Rider (age of rider is 60+) .
